ANTITRUST POLICY

The Processing Tomato Advisory Board, its members and staff, strictly comply with all State and federal antitrust laws. Should any meeting attendee observe discussions that involve antitrust sensitivity, the attendee should raise his or her concern and request the discussion be stopped. If the discussion continues, the discussion should be reported to the Board's CEO and Department staff.

Public Comment

Action may be taken on any item on the agenda. The time and order of agenda items are subject to change at the discretion of the Chair and may be taken out of order. In accordance with the Bagley-Keene Open Meeting Act (BKOMA), all meetings of the Board and its committees are open to the public (reference California Government Code § 11120 et seq.).

BKOMA Section 11125.7 provides the opportunity for the public to address each agenda item during discussion or consideration prior to action being taken on said item. Members of the public will be provided appropriate opportunities to comment on any issue before the Board, but the Chair may, at his or her discretion, apportion available time among those who wish to speak. Individuals may appear before the Board to discuss items not on the agenda; however, the Board can neither discuss nor take official action on these items at the time of the same meeting [BKOMA Sections 11125 and 11125.7(a)].
